Application dates: 4/1/23 - 4/20/23:

Alternate Application Dates: 4/21/23 – 5/11/23  
Target Pest: Crabgrass & broadleaf weeds

2-Late Spring: Fertilizer. Spot Control  
Application Dates: 5/1/23 – 5/20/23

Target Pest: Broadleaf Weeds  
Alternate Dates- 5/21/23 - 6/20/23

3-Grub Control/Preventative  
Application Dates: 6/1/23 – 6/20/23

Target Pest: Grubs, Chinch Bug, Mole, Cricket etc.  
Alternate Dates- 6/21/23 & 7/31/23

4-Summer- Fertilizer. Post Emergent Crabgrass Control.  
Weed Control  
Application Dates: 6/1/23 & 6/20/23

Target Pest: Crabgrass & Broadleaf Weeds  
Alternate Dates- 6/21/23 & 7/31/23

5-Late Summer- Fertilizer. Spot weed Control  
Application Dates: 8/1/23 & 8/20/23

Target Pest: Broadleaf Weeds  
Alternate Dates 8/21/23 & 9/10/23

6-Fall- Winter Fertilizer for Deep Root Growth.  
Spot Weed Control  
Application Dates: 9/16/23 & 10/6/23

Target Pest: Broadleaf Weeds  
Alternate Dates: 10/7/23 – 10/31/23

7-Fall- Pelletized Limestone. Spot Weed Control  
Application Dates: 9/16/23 – 10/6/23

Target Pest: Broadleaf Weeds  
Alternate Dates: 10/7/23 – 10/31/23

Cost per application = \$296.75  
Total Service Amount with Tax = \$2256.41
